Ashby Land Trust monitoring report for South Rd Fields. Needs to be amended – to note that the tree that was pruned is a horse chestnut. Discussion of the need for signs. The Commission has a "No Wheeled Vehicle" sign that could be put up.

#### **Old Business:**

David Bozza requesting a site visit and signature for a septic replacement at 875 Foster Road.

Follow-up on minutes sent out from the Watatic Management Committee Meeting on May 9, 2013. A sub-committee will be reviewing the site on May 21,2013 for what areas might be labeled with signage to try to protect it from abuse from visitors. Others will be reviewing the Management plan for potential areas that might require rewriting. There will be 3 meetings a year now – June, October and March. 2<sup>nd</sup> Thursday of the month.

Concerns about the cutting on Valley Road and the old stone culvert. Cathy visited site to view where the steel plates had been removed. All looks reasonable. The crew that was supposed to come and clear out slash for firewood has not removed the slash on the logging roads. Water is flowing through the culvert, unimpeded.
