In the name of the Commonwealth, you are hereby directed to notify and warn the inhabitants of the Town of Ashby, qualified to vote in elections and town affairs, to meet at the Elementary School Auditorium in said Ashby, Saturday, October 21, 2006 at 9:30 a.m. to act on the following articles:

SPECIAL TOWN MEETING ARTICLES

Article 1. To see if the Town will vote to appropriate the sum of \$364.80 from additional State Aid to the Prior Years Bills account for the purpose of paying a prior year bill, or take any action thereon.

Article 2. To see if the Town will vote to appropriate the sum of \$14,760 from additional State Aid to the Police Chief Salary account for the purpose of paying the police chief salary, or take any action thereon.

Article 3. To see if the Town will vote to appropriate the sum of \$33,830.20 from additional State Aid and to transfer the sum of \$1,094.80 from the Insurance account to the Police Wages account for the purpose of paying police wages, or take any action thereon.

Article 4. To see if the Town will vote to appropriate the sum of \$750 from the Insurance account to an Assistant Collector Wages account in order to pay for assistant collector services, or take any action thereon.
